- Any CCTV System installed at the premises shall be maintained in good working order and used at all times the premises remain open to the public for licensable activities. Any CCTV footage shall be kept for at least 14 days and available to the Licensing Authority or a Responsible Authority on request.
- All Existing External Security lighting shall be maintained in good working order and used where appropriate at all times when the premise remains open to the public.

- The Licensee shall ensure that all instances of crime and disorder are recorded in an incident logbook that is made available to West Yorkshire Police on request. West Yorkshire Police shall also receive regular reports of such incidents from the licensee.
