Hi Melanie,

Please see the below response I've received from the courts.

On 04/04/2019 SINGH committed the below offences resulting in his arrest.

- Drive Motor vehicle Over the Prescribed Limit (OPL) : 'Contrary to section 5(1)(a) of the Road Traffic Act 1988 and Schedule 2 to the Road Traffic Offenders Act 1988.'
- Drive otherwise than in accordance with a licence: 'Contrary to section 87(1) of the Road Traffic Act 1988 and Schedule 2 to the Road Traffic Offenders Act 1988.'
- Use Motor Vehicle – No Insurance : 'Contrary to section 143 of the Road Traffic Act 1988 and Schedule 2 to the Road Traffic Offenders Act 1988.'

After pleading Guilty he was obviously convicted on the 3<sup>rd</sup> May 2019. Amongst various fines etc. he was also Disqualified from driving or holding a driving Licence for 36 months.

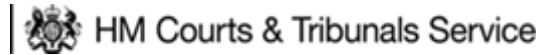
I have checked the Court file and cannot see any paperwork on file of Mr Singh being a licence holder or any disclosures made.

Good Morning,

The above case was heard at Bradford Magistrates Court and sentencing took place on 3<sup>RD</sup> May 2019. The offences were Drive whilst OPL and associated driving offences

The defendant is a Personal Licence Holder (alcohol) which was issued by Bradford Council.

I am enquiring as to whether this was disclosed to the Court during the proceedings as the defendant should have done so. The Court has a power to suspend or revoke this licence or pass details onto Council Licensing for them to take action should they decide to do so. It is an offence for Mr SINGH not to have disclosed that he holds a personal licence.

Could records be checked to see if this was ever disclosed during the case?
