1.0 SUMMARY

1.1 This report considers objections received to the recently advertised Bradford East Area-Wide Traffic Regulation Order.

2.0 BACKGROUND

- 2.1 At the meeting on 14 July 2021 the Bradford East Area Committee approved, as part of its Safer Roads schemes programme, the advertisement of an area-wide Traffic Regulation Order for 14 sites throughout Bradford East.
- 2.2 The Order has been promoted to address a number of requests for small areas of existing waiting restrictions to be amended or new parking restrictions to be introduced. The requests have been raised by local residents and businesses to resolve safety and access issues.
- 2.3 The Traffic Regulation Order (TRO) was advertised between 23 December 2021 and 14 January 2022. At the same time consultation letters and plans were delivered to residents and businesses directly affected by the proposals. This has resulted in objections to the proposals at 2 sites Folkestone Street, Bradford Moor and Hendford Drive, Bowling & Barkerend. Plans of the proposals that have received objections are attached as Appendices 1 and 2.
- 2.4 A summary of the valid points of objection and corresponding officer comments is tabulated below:

| Folkestone Street , Bradford Moor (Ward 6) Dwg No. HS/TRSS/104758/CON-6A Number of objectors 1 Objector – Alleges that one of the residents does not have a car and it will be used by other family members visiting the property and that the other does not have a car and is mobile/independent. The objector also points to the difficulties finding parking spaces within the area before any such formal BBPP's. | Folkestone Street There are existing informal Blue Badge Parking Places (BBPP's) at both the subject locations on Folkestone Street; these were both promoted and installed in accordance with the Council's approved process. Following concerns about the abuse of both the spaces by non-blue badge holders, requests to formalise these bays have been received. This would result in a minor change from the existing layout, with the individual spaces being increased in length by 1.6m each. The spaces would then be enforceable by the Council's wardens. |
| Hendford Drive, Bowling & Barkerend (Ward 5) Dwg No. HS/TRSS/104733/CON-10A Number of objectors 2 Objector 1-The objector states double yellow lines are to be placed outside his driveway and wishes them to be removed. | Hendford Drive The double yellow lines are proposed to address continued issues resulting from parking in the turning head at the end of Hendford Drive and blocking of the access gates to the Greenway. |

Objector 2-The objector states parking is at a premium in this area and that he parks there only because there is nowhere else to park. He suggests creating an alternative entrance nearer to Carlton Bowling school and that he often suffers abuse from Council workers who beep their horns as early as 7am and swear at residents!!

The proposed restrictions are the minimum required to maintain safe access to the Greenway for maintenance vehicles and, potentially, the emergency services. The proposed yellow lines also extend into the purpose-built turning head at this location to negate the need for vehicles to undertake unsafe lengthy reversing manoeuvres.

3.0 OTHER CONSIDERATIONS

3.1 Local ward members and the emergency services have been consulted on the advertised sites. No objections have been received.

4.0 FINANCIAL AND RESOURCE APPRAISAL

4.1 A budget of £13,000 has been allocated as part of the 2021/22 Safer Roads schemes programme. The estimated cost of the proposals is within this budget.

5.0 RISK MANAGEMENT AND GOVERNANCE ISSUES

- 5.1 A failure to provide an appropriate level of waiting restrictions on Hendford Drive would lead to ongoing access issues and the potential unsafe reversing manoeuvres due to the turning head being blocked.
- 5.2 If the current BBPP's on Folkestone Street are not formalised with a Traffic Regulation Order the residents here will continue to face access issues.

6.0 LEGAL APPRAISAL

6.1 The proposals contained in this report are within the Councils powers as Highway Authority.

7.0 OTHER IMPLICATIONS

7.1 SUSTAINABILITY IMPLICATIONS

There are no sustainability implications arising from this report.

7.2 GREENHOUSE GAS EMISSIONS IMPACTS

There is no impact on the Council's own and the wider District's carbon footprint and emissions from other greenhouse gasses arising from this report.

The introduction of some of the waiting restrictions in the Order will be beneficial in terms of road safety.
