Overview & Scrutiny Area:

1. SUMMARY

This report gives an update on West Yorkshire Pension Fund's (WYPF) pensions administration activities for the period 1 April 2023 to 30 June 2023.

2 Background

2.1 As well as providing pensions administration for WYPF scheme members, WYPF provides a full administration service to Lincolnshire Pension Fund, the London Borough of Hounslow, the London Borough of Barnet and to twenty three Fire Authorities. This includes pensioner payroll (except for the London Borough of Hounslow), all member and scheme level events, reporting to statutory bodies, provision of data to external bodies such as actuaries, and local authorities for the production of the scheme accounts.

5. Administration Update

5.1 Annual Benefit Statements (ABS) and Deferred Benefit Statements (DBS)

The statements are issued to members electronically via the secure 'MyPension' portal. However, members who have opted to receive a paper copy will be issued one to their home address.

As at 30 August 2023 99.2% of ABS's and 99.9% of DBS's have been produced for

WYPF members who are eligible to receive one.

- 5.2 Audits undertaken by Bradford Council's Internal Audit in the period:
 - a) NEW PENSIONS AND LUMP SUMS ILL HEALTH PENSIONS

It is audit's opinion that the standard of control of identified risks in the system is **excellent.**

The audit review has determined that the identified risks are being effectively managed. The control environment is as expected and supports the achievement of key business objectives.

- 5.4 WYPF have chosen Bravura to be our 3rd Party ISP Providers for the Pensions Dashboard. Work will start shortly to ensure our requirements are implemented by Bravura.
- 5.5 Recruitment

A number of appointments have been made to our pensions administration teams with some vacancies still to fill.

6. Staffing

- 6.1 WYPF headcount is 206 (196 full time equivalent staff) with an average age of 45.9 (Appendix F).
- 6.2 For the year ending 1 April 2023 the average number of days absence due to sickness is 6.11 per staff member. This compares with the Council average of 14.04 days (Appendix G).
- 6.3 There were 18 new starters during the last 12 months (Appendix H)
- 6.4 There were 9 leavers during the last 12 months (see Appendix I).
- 6.5 A number of recruitment exercises are ongoing to fill vacancies and also for new posts created as a result of increasing workloads.
