 - 3.1.1 Special Educational Needs and Disability (SEND) Local Offer First Annual Report 2014-15

The Chair has signed off the first annual report on the 'Local Offer' which was developed under the Children and Families Act (2014) which placed a new requirement on all local authorities to publish a Local Offer on 1 September 2014 and placed a statutory





requirement on the local authority to publish the first annual report on 31st August 2015.

The Local Offer must provide information on services across Education, Health and Social Care for children and young people who are aged 0 - 25 years and have special educational needs and/or disabilities (SEND). The Local Offer includes local provision and provision outside of the area that is likely to be used including regional and national specialist provision.

The purpose of the Local Offer is to provide clear, comprehensive and accessible information about the available services in the Bradford District and how families can access it. The aim is to make provision more responsive to local needs and aspirations by directly involving disabled children and young people and those with special educational needs, their parents/carers and service providers in its development and review.

The Local Offer has been co-produced with key stakeholders including young people from the Bradford district with SEND, their families' and with input from key service providers across Education, Health and Social Care. We hope that the Local Offer makes it easier for families to find information, provides clarity for families about the services that are available, enables families to identify any gaps in provision and will provide an evidence base for improving services in the future.

The Local Authority must seek and publish comments that are received about the Local Offer and publish these along with their response to those comments. Feedback must be sought on the content, accessibility and the development and review of the Local Offer.

3.1.2 Updates from the Board sub-groups

Update from the Integration and Change Board (ICB)

The Board received a programme update in relation to New Models of Care (Complex Care) reporting good progress with minor slippage in some workstreams - slippage is forecast to be made up as the programme work is gathering pace.

The method for agreeing the cohort for the complex care programme has been agreed. The Complex Care Programme Board agreed that 800 individuals be identified from across the Airedale-Wharfedale-Craven area, and for work to be commissioned to demonstrate proof of the concept of the proposed model.

Options for the contracting and procurement of this work were to be considered at the July Board. Performance outcomes will be included in an overarching outcomes framework for the CCG and a communications plan is in development.

3.4 Update on New Deal- Better Health, Better Lives

Better health better lives frontline event

Working together with front line staff and service users is vital if we are to be effective in building a more integrated health and social care system that meets people's needs within the constraints of available resources. Building on recent activity to engage with different stakeholder groups across the sector will help us share insights and expertise and more importantly develop new approaches and solutions to the issues we face. With this in mind we are currently planning an event to run as part of the better health better lives week, scheduled to run alongside self care week in week commencing 16 November 2015. Having shared the idea with Integration and Change Board the intent is to work closely with colleagues in both the health and voluntary and community sector to design and deliver this event. Details will be firmed up and invites issued this month.

3.5 Health and Wellbeing Board Annual Report to Bradford District Partnership

No comments were received from Board members on the draft 2014-15 Annual Partnership Report to Bradford District Partnership which was circulated following the July Board meeting. The report outlines work that has taken place under the direction of the Board including:

- highlighting the work on mental health and wellbeing and the Crisis Care Concordat, and





- the Board's commissioning of an integrated strategy for Physical Activity;
- forecasting the main areas of work for 2015-16 to be focused on system change specifically the development of a broader Commissioners' Alliance and development of a Providers Alliance;
- outlining future opportunities for partnership working including through the system change work commissioned at the July 2015 development session.

Board members are therefore asked to offer final comments and amendments today or to sign off the report - provided here as an appendix.
