

Further addendum to the previous Report of the Assistant Director, Office of the Chief Executive (document AR) to the meeting of Executive on 4 February 2020 to be presented to the meeting of Executive of the 18 February 2020.

Subject:

ADDITIONAL Consultation feedback received on new proposals in the Council budget for 2020-21.

1. Summary

- 1.1 The report (Document AR) of the Assistant Director, Office of the Chief Executive was published on 27 January 2020 and was presented to the Executive at the meeting held on 4 February 2020. The report included information from the public engagement and consultation programme in relation to the new budget proposals for the 2020-21 budget.
- 1.2 The public consultation and engagement programme continued until 26 January 2020 meaning that there was a requirement to provide details of further information and comments received from 23 January when the report was submitted for publication to the end of the consultation. The addendum provided an update on feedback received during these additional few days.
- 1.3 The addendum also provided feedback received from the trades unions.
- 1.4 Executive of the 4 February expressed the view that any further feedback received prior to the meeting on the 18 February 2020 should be presented as a further addendum to that meeting.

2. Updates to the feedback received through the consultation

2.1 In addition to the numbers in the published executive report, and the previous addendum there has been one further comment received on the budget proposals. This is included in Appendix 1 of this addendum.

- 2.2 No further feedback has been received from trades unions.
- 2.3 The feedback received relates to the proposed investment in tree planting. It also comments on litter and street flowers/plants, community safety, the City of Culture and a reduction in buses to Leeds. There is also a suggestion that funds should be put into health.
